WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-2591 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0409 re: Procurement of Tubeless Tires & Battery (Item No. 1, 3 & 4) for Mitsubishi Strada SKN - 810, SKN - 820, SKN - 840, SKP - 359 & 7AA-641, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 383,320.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 200 M AUTO REPAIR SHOP & PARTS has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare 200 M AUTO REPAIR SHOP & PARTS as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 2021-0664 (2nd Failure);
- b). To recommend award to 200 M AUTO REPAIR SHOP & PARTS in the amount of P 331,480.00 for delivery of goods/services under Negotiated Canvass No. 2021-0664 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
