WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0892; re; Procurement of Diesel Fuel for Regravelling of Cabanbanan Barangay Road, Dimiao, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 79,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
