BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL INFORMATION & MEDIA RELATIONS**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0932** re; **Procurement of Various IT Equipment for Live Streaming & Coverage of Provincial Government of Bohol Programs/Activities, by the GO - Provincial Information & Media Relation, New Capitol Compound, Tagbilaran City.** with an ABC of **P 267,500.00;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **136 ACTIVE EVENTS EQUIPMENT RENTALS** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **136 ACTIVE EVENTS EQUIPMENT RENTALS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **136 ACTIVE EVENTS EQUIPMENT RENTALS** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
