WHEREAS, the **OFFICE OF THE GOVERNOR - SPECIAL PROJECT SECTION** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2022-0064** re: Procurement of Rental of Sounds & Lights & LED Wall, by the Office of the Governor - Special Project Section, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of **P 660,000.00**;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


