

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0089 re: Procurement of Medicines & Supplies for Medical Outreach Mission in Relation to Recovery & Relief Efforts in Response to the HEART Caravan Program, by the Office of the Governor, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 4,790,522.40;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CEBU SURGICAL AND MEDICAL ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of CEBU SURGICAL AND MEDICAL ENTERPRISES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, CEBU SURGICAL AND MEDICAL ENTERPRISES has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare CEBU SURGICAL AND MEDICAL ENTERPRISES as the bidder with the **SINGLE CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022-0060, EMERGENCY CASES;
- b.) To recommend award to CEBU SURGICAL AND MEDICAL ENTERPRISES for the delivery of goods under Negotiated Canvass No. 2022-0060 EMERGENCY CASES in the amount of P 4,786,084.80;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
