

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0154 re: Procurement of Supplies & Materials for the Multiple Handline as Part of the Barang Bohol Recovery Effort of PGBh - OPA Brought by Odette, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogan District, Tagbilaran City, Bohol, with an ABC of P 700,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BRIGHTSTONE CONSTRUCTION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

- b.) To recommend award to BRIGHTSTONE CONSTRUCTION for the delivery of goods under Negotiated Canvass No. 2022-0093 EMERGENCY CASES in the amount of P 700,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
