WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. – PHO – 2020 - 394 re: PROCUREMENT OF PCR8-TUBE STRIPS FOR THE USE IN THE OPERATION OF THE BOHOL CONTAINERIZED PCR LABORATORY with an ABC of P 186,200.00;
