WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-002 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL AGRICULTURIST** in undertaking Procurement Request under PR No. 2021-0908 re: Procurement of Procurement of 4-Cylinder Turbo Intercooler Vehicle for the Use at the Agribusiness Division, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of **₱ 1,995,000.00**;
