

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL LEGAL OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0689; re: Procurement of Transportation Rental, by the Provincial Legal Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 60,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL ISLAND OPERATORS & DRIVERS MULTI PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL ISLAND OPERATORS & DRIVERS MULTI PURPOSE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its BOHOL ISLAND OPERATORS & DRIVERS MULTI PURPOSE COOPERATIVE has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Quotations and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare BOHOL ISLAND OPERATORS & DRIVERS MULTI PURPOSE COOPERATIVE as the supplier with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2021-0655;
- b.) To recommend award to BOHOL ISLAND OPERATORS & DRIVERS MULTI PURPOSE COOPERATIVE for the delivery of goods/services under Negotiated Canvass No. 2021-0655 in the amount of P 50,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


