WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2021-0006 re: Supply of labor, materials and equipment for the upgrading of power supply system at Cong. Simeon G. Toribio Memorial Hospital, Carmen, Bohol. with an ABC of P 1,676,548.15;


WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;

- c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


