WHEREAS, the CATIGBIAN DISTRICT HOSPITAL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2021-0055 re: Furnishing of Labor, Materials and Equipment for the Installation of Electric Power Connection at Catigbian District Hospital, Catigbian Bohol. with an ABC of P 1,632,315.64;

WHEREAS, above requisitioned goods are sold/distributed/provided by BOHOL I ELECTRIC COOPERATIVE INC.(BOHECO I) sole distributor of the aforementioned brand of products;

- b) To declare BOHOL I ELECTRIC COOPERATIVE INC.(BOHECO I) as the sole distributor of said products in the amount of P 1,632,315.14 under Direct Contracting Canvass No. 2021-0002; thus, recommendation for award is hereby conferred to;
- c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
