BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases
and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-204 re: PROVISION OF ROOM ACCOMMODATION FOR THE MEDICAL FRONTLINERS with an ABC of ₱ 903, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the single price quotation as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:
