BAC Resolution Declaring SCRQ through Negotiated Mode of Procuremen and Recommending Award

> RESOLUTION NO. 21-1495 Series of 2021

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-204 re: <u>PROVISION OF ROOM ACCOMMODATION FOR THE MEDICAL FRONTLINERS</u> WITH A BC of <u>P 903, 000.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the single price quotation as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> as the bidder with the <u>SINGLE CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>CATERING AND ACCOMMODATION SERVICES</u> under Negotiated Canvass No. <u>2021-177 (Emergency Case)</u>;
- To recommend award to <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P 900, 000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
