



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2022 - 018 re: PROVISION OF SERVICES FOR THE REPAIR OF X-RAY MACHINE with an ABC of P 67,200.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JBC I.T. MEDICAL EQUIPMENT AND SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare **JBC I.T. MEDICAL EQUIPMENT AND SUPPLIES TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 67,200.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. – PHO – 2022 – 008;
- b.) To recommend award to **JBC I.T. MEDICAL EQUIPMENT AND SUPPLIES TRADING** in the amount of **SIXTY SEVEN THOUSAND TWO HUNDRED PESOS ONLY (P 67,200.00)** for the delivery of goods under Negotiated Canvass No. – PHO – 2022 - 008;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
