WHEREAS, the ~~WELFARE AND DEVELOPMENT OFFICE~~ <sup>OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT</sup> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0153 re: Procurement of Sardines & Beef Loaf for outreach Mission/HEART Caravan, by the Provincial Social Welfare & Development Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 3,516,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

- To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the bidder with the SINGLE CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022-0092 EMERGENCY CASES;
- To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods under Negotiated Canvass No. 2022-0092 EMERGENCY CASES in the amount of P 3,515,200.00
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
