WHEREAS, the PROVINCIAL TREASURY OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0157 re; Procurement Delivery Receipts, by the Provincial Treasury Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 210,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ST. JUDE PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
