WHEREAS, the GO-SPECIAL PROJECT SECTION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0196, re; Procurement of Sounds & Lights & LED Wall Rental for Annual Events/Celebrations, Projects & Program of the PGBh, by the Office of the Governor - SPS, New Capitol Compound, Tagbilaran City. with an ABC of P 540,000.00;
