**BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2022-0205** re: Procurement of Various Electrical Materials for the Replacement of the Damaged Materials due to Typhoon Odette, by the Provincial General Services Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 944,879.27;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to **PRIM E CONSTRUCTION SUPPLIES TRADING** for the delivery of goods under Negotiated Canvass No. **2022-0118** EMERGENCY CASES in the amount of **P 943,177.05;**
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
