



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 - 043**, re: **PROCUREMENT OF TIRES, BRAKE PADS, AND HORN ASSEMBLY**, with an ABC of **P 94,910.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JETS MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **JETS MARKETING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 94,872.00** for the **DELIVERY OF GOODS/SERVICES** under **Negotiated Canvass No. - PHO - 2022 - 019**;
- b.) To recommend award to **JETS MARKETING** in the amount of **NINETY FOUR THOUSAND EIGHT HUNDRED SEVENTY TWO PESOS ONLY (P 94,872.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2022 - 019**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


