WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-070 re: PROVISION OF ACCOMMODATION, MEALS AND SNACKS FOR THE HRMDO MID-YEAR ASSESSMENT with an ABC of ₱ 160, 000.00;
