BAC Resolution Declaring SCRQ through Agency-to-Agency and Recommending Award

WHEREAS, the **GOVERNOR'S OFFICE – SPECIAL PROJECTS SECTION** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-085** re: **PROVISION OF MEALS AND ACCOMMODATION FOR THE DISASTER PREPAREDNESS & RESILIENCY SEMINAR FOR BARANGAY STAKEHOLDERS** with an ABC of **₱ 1,699,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BADIANG SPRING RESORT AND HOTEL** offered the single price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

- b). To recommend award to **BADIANG SPRING RESORT AND HOTEL** for the Catering Services of the aforementioned request in the amount of **₱ 1,699,000.00**;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
