WHEREAS, the BOHOL PROVINCIAL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL procurement under Purchase Request No. 2022-108 re: PROVISION OF CATERING SERVICES & FROM SERVICES & PROVISION OF CATERING SERVICES MARKETING & PROMOTIONS THROUGH HOSTING MEDIA FAMILIARIZATION with an ABC of P 140, 000,00
