WHEREAS, the **BOHOL PROVINCIAL TOURISM OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-108** re: **PROVISION OF CATERING SERVICES & VENUE FOR MARKETING & PROMOTIONS THROUGH HOSTING MEDIA FAMILIARIZATION** with an ABC of **₱ 140,000.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL BEACH CLUB/ BOHOL RESORT DEVELOPMENT, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;


