## **BAC Resolution Declaring LCRQ and Recommending Award**

RESOLUTION NO. <u>22-07-12</u> Series of 2022

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-119 re: <u>PROVISION OF CATERING SERVICES DURING THE BARANGAY HEALTH WORKER PROGRAM</u> with an ABC of ₱ 249, 600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA</u> <u>GARDEN SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PANDA TEA GARDEN SUITES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>PANDA TEA GARDEN SUITES</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;
