



BAC Resolution Declaring SCRQ and Recommending Award

WHEREAS, the GOVERNORS OFFICE – SPS of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-003 re: PROVISION OF MEALS IN RELATION TO RECOVERY & RELIEF EFFORTS IN RESPONSE TO SUPER TYPHOON with an ABC of ₱ 750,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES, INC. offered the single price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
