BAC Resolution Declaring SCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE-SPS of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-008 re: PROVISION OF ROOM ACCOMMODATION & MEALS FOR THE GUESTS, STAKEHOLDERS AND DEVELOPMENT PARTNERS with an ABC of ₱ 495,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES, INC. offered the single price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
