WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-028 re: PROVISION OF CATERING SERVICES DURING THE INTER-AGENCY INTELLIGENCE FUSION, COORDINATION MEETINGS, STRATEGIC & OPERATIONAL PLANNING WORKSHOP, PERFORMANCE ASSESSMENT, CAPACITY DEVELOPMENT, TECHNICAL TRAININGS & SEMINARS AND OTHER RELATED COLLABORATIVE ACTIVITIES FOR LAW ENFORCEMENT AGENCIES with an ABC of ₱ 512, 500.00;
