WHEREAS, the OFFICE OF THE GOVERNOR- BIPC of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-052 re: PROVISION OF CATERING SERVICES DURING BUSINESS DEVELOPMENT: CAPDEV FOR FOOD INDUSTRY SECTOR, BEST SERIES, BOSS CARAVAN, SET-UP OF FOOD SAFETY HELPDESK, REPOSITORY OF INVESTMENT DATA/INFO, MAPPING with an ABC of ₱ 52, 500.00;
