WHEREAS, the GO EDUCATION DEVELOPMENT CENTER, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0029, re; Procurement of Medal, Metal with PGBh Logo for use of the Education Development Center(EDCenter), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 195,000.00;
