BAC Resolution Recommending the Use of Negotiated Procurement through Small Value Departing Lower Caralysis and Recommending Approval

WHEREAS, the GO EDUCATION DEVELOPMENT CENTER, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0029 re; Procurement of Medal, Metal with PGBh Logo for use of the Education Development Center(EDCenter) Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 195,000.00;
