

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the 60 - EDUCATION DEVELOPMENT CENTER, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0030 re: Procurement of Bag, backpack, color blue with PGBh Logo for use of the Education Development Center(EDCenter), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 599,970.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SOFIA PLUS TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of SOFIA PLUS TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, SOFIA PLUS TRADING has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
