WHEREAS, THE OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0819; re: Procurement of Sticker for IEC Materials, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 510,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- d.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


