

**BAC Resolution Recommending the Use of Alternative Mode of Procurement through Shopping in case of Unforeseen Contingency, Single Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0310, re: Procurement for the Siphoning of Septage/Sludge, Hauling/Transport of Sludge from Location to Dao, Daus & Treatment, by the Provincial General Services Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 100,000.00;




