WHEREAS, the OFFICE OF THE SP BOARD MEMBER RICKY UY MASAMAYOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0116 re; Procurement of Various Office Supplies & Sporting Goods, by the Office of the Board Member Ricky Uy Masamayor, New Capitol Compound, Tagbilaran City, with an ABC of P 134,680.40;
