BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GO-CENTER FOR CULTURE & ARTS DEVELOPMENT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0160 re; Procurement of LED Wall Rental & Sound System & Light Rental for Annual Commemorative Events/Activities Celebration, by the Center for Culture & Arts Development, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 136 ACTIVE EVENTS EQUIPMENT RENTALS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 136 ACTIVE EVENTS EQUIPMENT RENTALS including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation 136 ACTIVE EVENTS EQUIPMENT RENTALS has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare 136 ACTIVE EVENTS EQUIPMENT RENTALS as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022-0099;
- b.) To recommend award to 136 ACTIVE EVENTS EQUIPMENT RENTALS for the delivery of goods/services under Negotiated Canvass No. 2022-0099 in the amount of P 295,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




