GARCIA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0215, re; Procurement of Various Office Supplies, by the Office of Board Member Frans Gelaine C. Garcia, New Capitol Compound, Tagbilaran City. with an ABC of P 137,640.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DELMA ENTERPRISE, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


