BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0231, re: Procurement of Rice & Cellophane for the Relief Operation in Relation to Typhoon Odette, by the Office of the Provincial Social Welfare & Development, Tamblot Street, Tagbilaran City, Bohol, with an ABC of P 1,007,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that FNC TRADING AND RICEMILLAND RICEMILL offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of FNC TRADING AND RICEMILL including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, FNC TRADING AND RICEMILL, has been found to be ELIGIBLE and its bid, RESPONSIVE;

- a.) To declare FNC TRADING AND RICEMILL, as the bidder with the **SINGLE CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022-0159, EMERGENCY CASES;
- b.) To recommend award to FNC TRADING AND RICEMILL for the delivery of goods under Negotiated Canvass No. 2022-0159 EMERGENCY CASES in the amount of P 999,900.70;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
