BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0239 re: Procurement of Fuel (Diesel & Unleaded), by the Provincial Disaster Risk Reduction & Management Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 1,222,784.16;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL JL DISTRIBUTION SYSTEM INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL JL DISTRIBUTION SYSTEM INC., including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, BOHOL JL DISTRIBUTION SYSTEM INC., has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BOHOL JL DISTRIBUTION SYSTEM INC. as the bidder with the SINGLE CALCULATED AND RESPONSIVE QUOTATION, for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022-0166 EMERGENCY CASES;
- b.) To recommend award to BOHOL JL DISTRIBUTION SYSTEM INC. for the delivery of goods under Negotiated Canvass No. 2022-0166 EMERGENCY CASES in the amount of P 1,222,729.40;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
