**WHEREAS**, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0410, re; Procurement of Various Spare Parts, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 366,270.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




