WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022 - 089 re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of P 881,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Single price quotation as reflected in the Abstract of Bid Quotations,
