



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2022 – 102 re: PROCUREMENT OF BATTERY & TIRES with an ABC of P 60,000.00.
