

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL . of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 102 re: PROCUREMENT OF BATTERY & TIRES with an ABC of P 60,000.00.
