WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022 - 111 re: PROCUREMENT OF BENZOIC ACID & SALICYLIC ACID with an ABC of P 300,000.00;


