WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-075 re: PROVISION OF CATERING SERVICES DURING THE CAP DEV. PROGRAM IMPLEMENTATION REVIEW, ADVOCACY/ IEC, WOMEN FOR DISABILITY MONTH, MEETING/ ASSEMBLY FOR PWD, PCDA & PAMT with an ABC of P 311, 625.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ALTA CEBU VILLAGE</u> <u>GARDEN RESORT, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
