## **BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the <u>PROVINCIAL PLANNING AND DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-111 re: <u>PROVISION OF MEALS AND SNACKS DURING THE BOHOL ENERGY DEVELOPMENT ADVISORY GROUP MEETING & OTHER RELATED ACTIVITIES OF BEDAG with an ABC of P 199, 800.00;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
