WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-111 re: PROVISION OF MEALS AND SNACKS DURING THE BOHOL ENERGY DEVELOPMENT ADVISORY GROUP MEETING & OTHER RELATED ACTIVITIES OF BEDAG with an ABC of ₱ 199, 800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
