**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 16<sup>th</sup> day of June, 2022 between Provincial Social Welfare and Development Office of Provincial Government of Bohol (hereinafter called the "Entity") and PANDA TEA GARDEN SUITES of 0655 J.A. Clarin St., Dao District, Tagbilaran City, Bohol (hereinafter called the "the Supplier").
