WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-177 re: PROVISION OF ACCOMMODATION FOR THE PARTICIPANTS OF THE LOCAL DRRM PLANNING, FORMULATION AND WRITESHOP FOR PDRRMC FIRST SESSION with an ABC of ₱ 258,000.00;
