WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-231** re: **PROVISION OF MEALS FOR THE ABANTE BOHOL BUSINESS DIALOGUE: GOVERNANCE TRANSITION TOWARDS CONTINUITY & SUSTAINABILITY OF PGBH DEVELOPMENT PROGRAMS AND PROJECTS** with an ABC of **P 125, 000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **MODALA BEACH RESORT** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
