WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0873 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL ACCOUNTING OFFICE** in undertaking Procurement Request under PR No. **2021-0633** re; Procurement of Various I.T Equipment, by the Provincial Accounting Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of **₱ 199,800.00;**


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:


